## Consent Form for Digital Sketching Research Project

I intend to identify and teach successful strategies for design drawing from contributed examples.

Total time required is from 3-5 hours. There are no known risks. While there is no guarantee that you will personally benefit from this research, you may gain insights about drawing when discussing your work and others' work. Benefits to others include the ability to examine the drawing process of exemplary renderers.

Drawings that you create as part of this study will be shown to others and will be published on a web site. Please indicate at the end of this form whether you would prefer to remain anonymous or if I may publish your name with your drawings. Names will not be attached to other information provided

Your participation is voluntary. Your decision whether or not to participate will not affect your relationship with the University of Oregon. If you decide to participate, you are free to withdraw your consent and discontinue participation at any time without penalty.
