1. - 8. The Editors shall deliver to the Publisher on the prescribed date a completed Promotional Questionnaire which shall have been previously supplied by the Publisher.
- 9. The Publisher shall pay the Editors the following royalties:

First and subsequent hard and/or softbound editions

(a) **12%** of net sales receipts on all copies sold worldwide (except through special sales).

Special sales

(b) **6%** of the net sales receipts from special sales. (Special sales are sales of any edition to one purchaser at discounts of 45% or more where initial sale to that purchaser is 100 copies or more.)

Translations

(c) **30%** of the royalties paid to the Publisher if the Work is translated into other languages.

Royalties shall be divided equally between the Editors.
